- Wenvoe PC were unable to enter the 2019 Welsh Cup for Clubs due to being unable to raise a team.

- Only 2 Teams entered in the League, again due to difficulties raising teams. The Dragons came second to last in the First Division, so are facing relegation for 2020. However, the Raiders won the Second Division, so will be promoted in 2020.
- Once again the Club were unable to host any WPA competitions due to the ongoing venue issue. It was decided to try to approach the pub management to look to hosting the WPA National Doubles competition in 2020 (scheduled for August 2<sup>nd</sup>) to see how it goes.
- Thanks to Bob and Dave for their work on the Committee and to Bob for maintaining the Club's website. Thanks to Dai for continuing to supply the refreshments on Sunday mornings, and for standing in as Treasurer.
